# Minutes:

## 1. Discussion Items

- a. Debrief Jan 24 Kickoff McCall
  - What needs improvement for stakeholder communication/outreach?
    - Create more space for small breakout sessions
  - Attendance at kickoff from VC Planning & Zoning, County Commissioners, USFS
- b. Plan Feb 15 NFPRWC Workshop 4-6PM
  - Donnelly Bible Church is available and has plenty of space for a large crowd. \$100 donation appreciated. Donnelly Fire Station, local school classrooms, and Idaho First Bank are also options.
  - Lenard Long: Hybrid option is important for this meeting.
  - Maureen Pepper: "If there is an opportunity to have a table of information at the kickoff on funding I would suggest this. NRCS has lots of info and funding."
  - IDFG partnership: insights, talking points for workshops
    - Need info from NR agencies about current watershed projects for potential land use map
    - Jordan M: "Here is what I see as the logical progression of content, to be spread across multiple meetings. 1. History where have we been and what has been done? 2. Current status of the watershed. 3. Types of projects that could address current conditions. 4. Funding sources to address these types of projects."
  - Potential workshop content: stormwater dialogue, Planning and Zoning related
  - Review <u>draft agenda</u> for edits, input
    - Revisit presentations from Dani Terhaar (confirmed State of the Watershed) <u>Jaap Vos</u> (possible, what content should he focus on?)
      - Dani T presentation: will focus on pressure on the environment, talk about community change impact on the watershed, will be careful not to place blame
      - Potential deep dive on different watershed issues in upcoming workshops
      - IDFW might follow up the State of the Watershed with historical projects and upcoming projects (30-40 mins) but this would not happen in time for Feb 15 workshop.
      - Lenard Long: Need an "old timer" presentation by Art Troutner or Lance Holloway -IDEQ to give a historical watershed address before Dani T presentation.

- Dani T on roundtable discussions: "Start with the word cloud. Start with the prompt we will brainstorm these questions. End with capturing responses."
- Judy Anderson: Be aware of getting public input on problems and then not meeting their expectations. This can upset people.
  - Lenard Long: stakeholder groups can be responsible for getting grant plans and money and in some cases, the District can apply for matching grants that prioritize load reductions.
  - Maureen Pepper: DEQ has money for these projects. There are few community groups available to shepard these projects. (Rural Community Assistance Program) The Coalition may also focus on finding money for projects later on.
- Review drafted outreach materials (interactive map email, <u>poster</u>, <u>event sign up email</u>, thank you memo)
  - finalize the "elevator pitch" we use to get people to attend (what will they do, why should they attend, etc. use for STAR-NEWS article)
    - brainstormed and came up with bullet points to start marketing push
