- 1. Guests and Guest Organization introductions and updates
 - a. Janet G Cherry, PE, Senior Environmental Engineer and her technical assistance team introduced the Closing America's Wastewater Access Gap, Technical assistance grant and selection of VSWCD and SLRWSD. Their role will be to assist with assessment, technical studies and community outreach needed to support SLRWSD. Next steps include outreach with SLRWSD, Valley Co BOCC for using the CAWAG to evaluate options for improving sewer services within the district. VSWCD will join SLRWSD monthly board meeting on June 21, 7 p.m. and Valley Co BOCC on June 24, 3:15 p.m.

 - c. Deb Feraday, president of Big Payette Water Quality Council advised board of research done and wave action on near shore: present study and research on July 8th and 11th at 6:30
 - d. ISWCC Megan Brooksher informed the board that Loretta Strickland taking on a new role within ISWCC of Agricultural Program Manager. Megan also advised on due dates for the ISWCC District survey, Financial match report (all District donations to be included on match report are due June 28, WQPA update (Lake Fork Irrigation District submitted. VSWCD application submitted to fund ICC crew for Willow Creek WMA fire mitigation Project with USBR 2024 Fire Mitigation funds was rejected for WQPA, Lake irrigation project still in the mix)- June 28th deadline for local support funds, financial and match support due August 16th, district survey due July 31st due. Megan will be out of the office June 19th-26th

 - f. Bill Lillibridge provided an email Heinrich update regarding permitting progress.for larger project scope
 - g. New managing supervisor for the no-till drills (large and small) and land plane will be Colt Brown, taking over for Bill Leaf. The district had 4 2024 spring no-till users. Discussion and decisions were made about landowner checks to be deposited for drill use and deposit checks to be returned from use and return of no till drills. One drill required repair which the landowner performed and paid for parts.
 - h. NFPR Watershed Coalition workshop June 12 update, Steering Committee meets @ 1 p.m. today. Ongoing onboarding of new Coalition administrator Kim Mapp Thompson.
 - i. Cities of Cascade, Donnelly, and McCall Agenda review- expansion of marina still up in air... regular agenda review by everyone and bring back to Board and activity that concerns VSWCD or requires comment.
 - j. Neil Shippy gave update on reservoirs and water status, .24cfs small vs. Large water rights, domestic water rights vs. Irrigation water rights.
 - k. Lenard Long provided FoLC Lake Cascade May update, overall water conditions looking good. Pam Pace provide an update on water flow.

S696 Strand Access Bank Restoration Alzar visiting student group (from Boston partner school) will have a strand project introduction and work day on June 17th and Alzar bank willow planting on June 18th with IDFG staff and 7 volunteers. The project introduction will include a Strand tour, KWP tour, IDFG classroom presentation on willow cutting/planting, tools and gear to be used.
